A set of optional site-visits to leading industry players in the Frankfurt area and social events throughout the week at the Frankfurt School campus will offer plenty of networking opportunities.

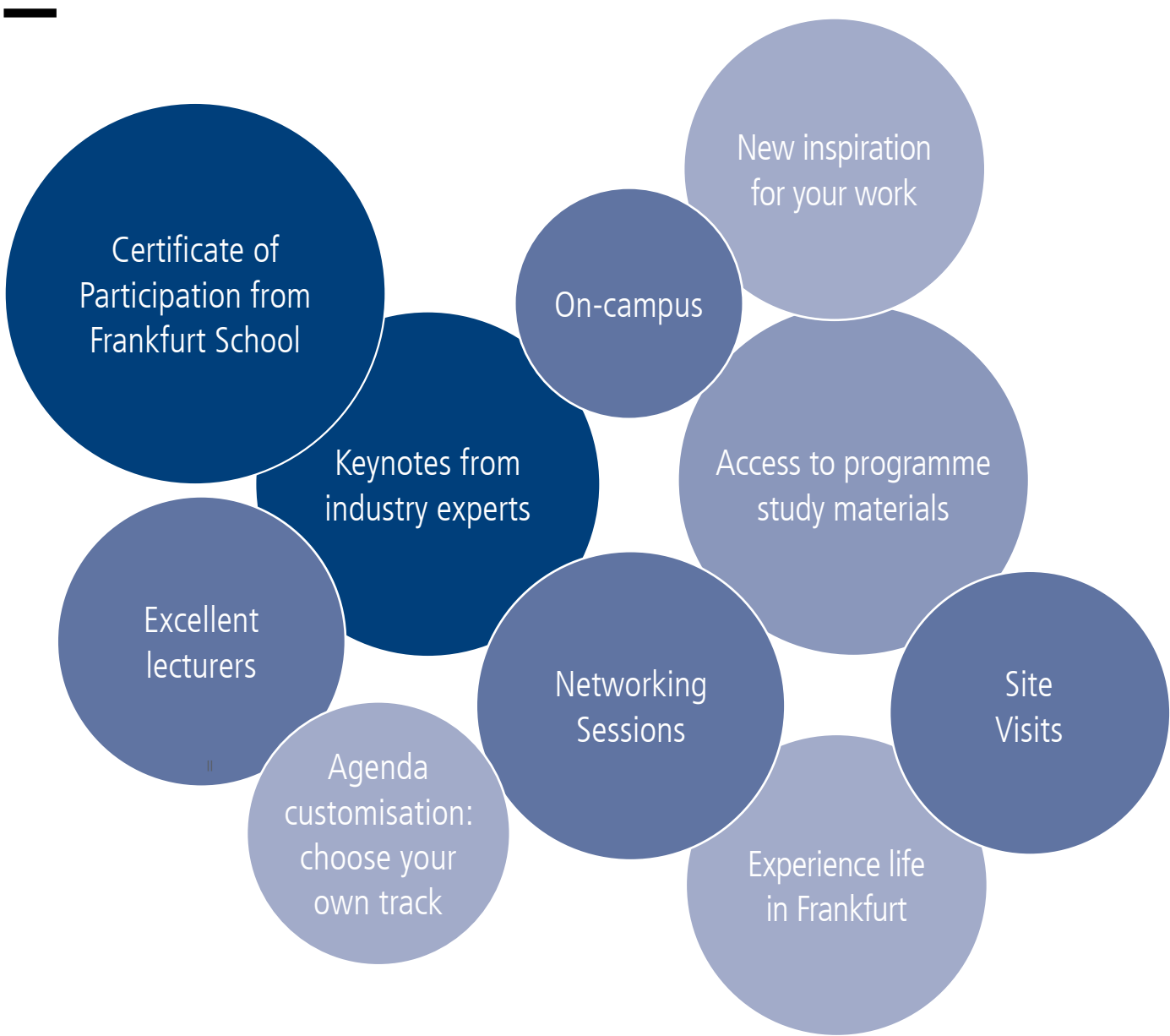

# THE PROGRAMME IN A NUTSHELL...

Financial services providers are undergoing rapid change. Many face increasing competition, tougher regulation or are branching out to embrace new market segments.

The Summer Academy will cover key industry trends and emerging challenges for financial firms in emerging markets. This year we will offer a unique format of high-level panels and four specialist tracks.

Summer Academy seeks to equip participants with profound technical know-how in one of five possible elective tracks. The Summer Academy is:



## INDIVIDUAL

Participants have the choice between a range of technical tracks to personalise their learning journey

## PROFOUND

Sufficient time is allotted to complex technical subjects

## INTERACTIVE

The teaching methodology is based on lectures, group work, case-studies, discussions and presentations

## REAL-WORLD

Hand-selected lectures with many years of exposure in the field share their experience

## Technical Track Options

The Summer Academy allows you as the participant to choose your own agenda. Network with the wider academy, but attend live sessions with industry experts, which closely align with your industry, organisation and personal development goals.

### Risk Management: Data driven survival skills for inclusive financial services

The risk environment for emerging market banks and other financial firms has shifted profoundly. The pandemic crisis has left many firms with excess debt as the usual tools of enforcement and restructuring were suspended. This is now compounded by a global commodity price shock, and renewed concerns over the economic outlook. The proliferation of climate change risks, digital finance technologies and the growing scrutiny of AML issues present additional challenges which risk managers need to manage proactively.

### Sustainable Finance

Climate change and the investment required in the low-carbon transition will redefine all parts of the financial sector. We will explore the physical risks that result from climate change, and the various tools and data that are now available to assess and manage such risks. We will also explore green lending and refinancing opportunities (such as green bonds) which are now increasingly contested by financial firms in both advanced and emerging markets.

### Inclusive and Digital Finance

The pandemic crisis and the ongoing shock to global commodity prices represent a serious setback to poverty reduction and financial inclusion. We will explore key trends in digital finance, financial inclusion policy and the microfinance community. Guest speakers will offer insights from the leading development institutions, and reflect on trends in policy, regulation and the industry globally.

### Sustainable Agriculture Finance

In the Sustainable Agriculture Finance Track we will look at both sides of the finance equation: demand and supply. What do farmers and agribusinesses need in terms of financial services, and what can financial institutions offer? The focus will be on smallholder farmers and sustainable agriculture in emerging markets. We will look at various practical examples how financial institutions can help to improve farm productivity and farmer incomes, labour conditions in the sector, the management of farm and supply chain risks, food security and safety, adaptation to climate change, reduction of greenhouse gas emissions and other pollutants, as well as biodiversity. In terms of financial services, the sessions will concentrate on credit, insurance, value chain finance, and digital solutions.



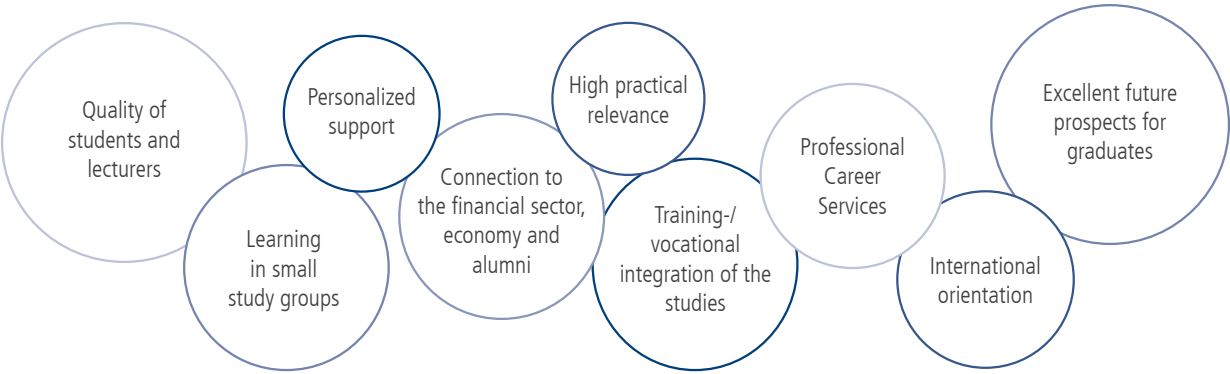

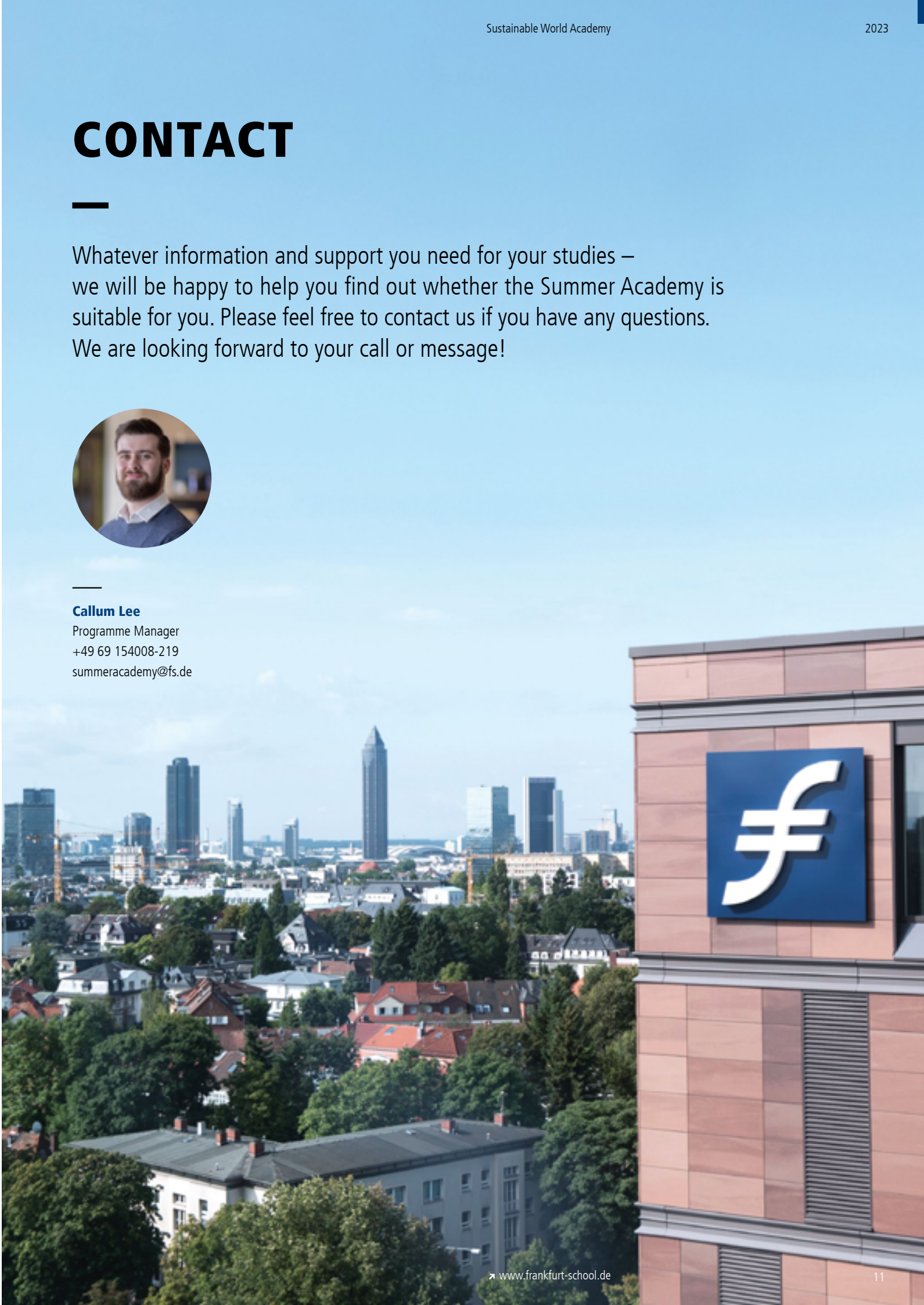
